

## Privacy Policy

(Effective May 2018)

Eckankars Svenska Satsangsamfund (Eckankar in Sweden) has a firm commitment to your privacy. You can visit our website [www.eckankar.se](http://www.eckankar.se) without telling us who you are or sharing any personal information. The following questions and answers explain when and how personal information is collected and used.

### What personal information does Eckankar in Sweden collect?

Eckankar in Sweden collects personally identifying information, such as your name, mailing address, email address, telephone number, and/or credit-card information, if you choose to provide that information by

- signing up to receive email or other mailings from Eckankar in Sweden (no credit-card information requested)
- preregistering for a seminar or similar gathering

We also receive your contact information from Eckankar's parent church in the United States if you have requested information about local events from the parent church or if you are a member of Eckankar.

### Does Eckankar in Sweden sell or rent my personal information?

Absolutely not.

### Will I receive unsolicited email from Eckankar in Sweden?

We do not send unsolicited email.

You may unsubscribe from email from us or Eckankar at any time by clicking on the unsubscribe link provided in the email, or contact us some other way.

### How is my personal information protected?

Safeguarding the information you give us is a priority.

We take appropriate security measures to protect against loss, misuse, unauthorized access, alteration, disclosure, or destruction of your information.

### How long is my personal information retained?

Eckankar in Sweden keeps your information as long as needed for the purposes outlined in this Privacy Policy, to resolve questions, and as necessary to comply with legal obligations.

### Does Eckankar in Sweden share my personal information with others?

Eckankar in Sweden does **not** share your personal information with others except in these cases:

- Such information may be shared with authorized leaders of Eckankar to fulfill your requests, administer contact lists, and coordinate activities. All such recipients

sign a data-privacy agreement and may only process your personal data for the purposes given in this Privacy Policy and according to local law.

- Personal information may be shared as needed with third-party companies for the sole purpose of providing services that help us fulfill your request (e.g., a seminar hotel). They are contractually required to provide strict security to the handling of personal information.

### **Is there any automated data processing on Eckankar in Sweden's website?**

#### **Cookies**

Our website does not use cookies.

### **Does Eckankar in Sweden collect information from children?**

No, we do not knowingly collect information from visitors age 17 and under. If you believe your child has provided Eckankar in Sweden with their personal information without your permission, please contact us so the information can be removed.

### **What are the bases for collecting and using my personal information?**

- Your consent so that we can inform you about Eckankar news and events
- As necessary to fulfill your requests and transactions
- As a nonprofit religious organization and church to administer membership records and matters
- If required by law or pursuant to legal process or other legal obligation
- When it is necessary to protect the vital interests of you or another person

### **What are my rights regarding personal information I give to Eckankar in Sweden?**

Eckankar in Sweden provides you with reasonable access to the personal information you gave us as well as the ability to review, correct, and delete such personal information to the extent required by law. You have the right to lodge a complaint with the applicable government agency if you believe your information has been used in a manner inconsistent with your privacy rights.
